Paper Specifications(160 points):

This paper must be at least 5 pages in length (not including charts, graphs or images). Writing must fill the entire page (To avoid losing points for length you may want to go onto the 6th page). These pages are to be 1.5” spaced, have standard 1” margins and be typed in 12 pt font Times New Roman).

The paper will be made up of 4 sections (Introduction, Summary, Analysis and Conclusion). The Introduction and Conclusion sections are not to exceed a page each in length. Questions to be answered in each section are listed below:

Introduction (20pts): Why did you choose this case? (One paragraph not exceeding one half of one page)

Summary (50pts): What is this Supreme Court Case about? What are the main points? How did this Supreme Court Case affect the United States?

Analysis (50pts): How did this Supreme Court Case impact your views on this issue? What are their implications of this Supreme Court Case and based on the Constitution and Bill of Rights, do you think this Supreme Court Decision was Constitutional and why?

Conclusion (20pts): Why is this Supreme Court Case important to the lives of the American people?

Notes on Cover Page and Works Cited (20 points)

All resources used must be listed in a Works Cited Page and documented parenthetically using MLA 8 Style formatting. Please use a **minimum** of FIVE sources and do not use Wiki sources for your paper. Sources must be sent to Mrs. Hoffman PRIOR to your completion of the project. You may send him your research sources to lhoffman@berkscatholic.org. Please have your sources researched and approved NO LATER than Aug. 1.

Please do NOT have a heading on the first page of text for your paper, this is different from what you do in English class! A cover page must be the first page of the document and must include your name, date, and name of the Supreme Court Case you researched. The paper will be the 5 pages after the cover page and the works cited will be the page after that. In total, the requirement is 7 pages that must be submitted to Canvas the FIRST WEEK OF SCHOOL.

Presentation (40 Points)

Students will be required to make a 4 to 7 slides in Google Slides with title slide (not part of the 4 to 7 total). This will be used as the visual aid for the minimum 5 minute presentation of the Supreme Court Case that will be conducted the first quarter of class. Google Slide presentations are to be on the student's iPad. Presentations will begin in the First Quarter. Students will be graded on their presentation when it is given before class. Students who are not prepared are who fail to present will have points deducted from their presentation grade. Presentations should include bullet points, pictures (minimum FIVE), and follow the format of the paper- Introduction, Summary, Analysis and Conclusion.

Your papers must be submitted into Canvas NO LATER THAN the Friday of the first week of school. Mrs. Hoffman will remind students the first day back to upload completed papers.
